- Subsidy is given on a year to year basis. You must apply for each year separately. Approval in one year does not guarantee that the subsidy will be automatically approved for future years.
- There are limited funds available and applications are processed on 'first come first serve' basis. If the application is incomplete, supporting documents are missing or the completed application with documents is not submitted to mujtaba@academyofislam.com by the deadline, then applicant will lose their priority order and be placed at the end of other applicants.
- Please be advised that the Subsidy will not be back dated for late applicants. Full fees are payable
